Item 6	Local planning applications	
	(i) 23/00085/OUT Outline Planning Application (with All Matters Reserved Except Access) for the Erection of 15 No. Residential Dwellings DEFERRED – reconsultation.	

The chair introduced the item which is an application to build 15 houses on land off Wild Hill. The original application was made in February '23, a number (c20) objections were lodged in response to the original consultation. Following a request made by Cllr Jones the matter was considered by the Planning Committee on 12/10/23 when a decision was deferred as some major issues raised. A revised application has been posted and a reconsultation process is underway with a deadline of 22nd January. It is expected the matter will be considered by Planning Committee on 8th February.

The four primary areas of concern of the Parish Council were outlined:

Surface water

The new proposal now shows surface water from the site connecting into the surface water sewer on Greenacres. The outfall then flows directly into Hunton Beck in the middle of the play and recreation area, just upstream of a Zone 3 flood risk area, which will add to heavy flooding in the centre of the village. This already occurs on regular occasions as is well documented. We believe that allowing further surface water to discharge into the beck is totally unacceptable and will lead to more severe flooding.

Foul Water

The new proposal shows the construction of a new foul water sewer running from the site entrance down Wild Hill, along Greenacres and then connecting into a mains sewer on Ratten Row. This proposal is untenable as the land at the end of Greenacres is privately owned and permission would not be granted.

At the Planning Committee meeting, concerns were raised around how drainage could be delivered due to the topography of the site. The current application shows the housing being pushed into the northern edge of the plot which is the lowest point, and the proposal relies heavily on the use of pumped systems maintained by a third-party, private management company. This is a high-risk strategy and given the close proximity of the development to the existing houses on Greenacres could place these properties at risk of pollution/flooding should there be a pump failure or blockage. The odour from these pumps could also be an issue.

Detailed Highways and Public Right of Way Information

The report now acknowledges that the statements made by the Parish Council at the Planning Committee meeting on the 12th October 2023 were correct in that although a public footpath is shown on an OS map it has no link into the village due to the construction of houses on Wyville Grove by RDC some 60+ years ago. The proposal is now to connect into the short length of path

at Broadacres but this does not provide a direct link to the village. Despite the developers claims that they are enhancing footpath links to the village there is absolutely no material change. The developers plan which shows the provision of a stile on the southern edge of the site to route the path which exists on paper some 500m to the south, and then exiting onto Wild Hill Lane which is single track and has no footpath. This is non sensical and does nothing to connect the development to the village.

Affordable Housing and Alternatives

National guidance states that rural development should be in response to local need and the response should most suitably be by rural exception sites, a requirement that was fully met with the Broadacres development. At the time the **Broadacres** development was being considered it was acknowledged by RDC officers that this was a special exemption site, beyond the designated building line and would not lead to the floodgates opening for larger scale development in the future. On this understanding, the Broadacres 'social housing for rent' development, was welcomed by residents and actively pursued on their behalf by the Parish Council, because it was for local people, who could not afford to buy, it was in keeping with the traditional character of the village, a classic Yorkshire linear settlement, and it was modest in size.

Members of the public present asked questions and it was confirmed any resident can raise objections to the application and Cllr Jones encouraged people to submit views whether supportive or to object. It was confirmed that anyone at all could make an objection; those who objected initially mostly received letters, but that did not mean others could not object.

(ii) ZD23/00642/FULL NB response to consultation by 5/01/24

This application is for change of use of a barn at Old Hall, consultations were due by 5th January 2024, the Parish Council had responded and asked that issues regarding drainage and whether existing septic tank is non-compliant and that the development was solely for private use.

(i) Hunton in Bloom		(i) Hunton in Bloom	

The HIB representatives advised this year they plan to enter for Village in Bloom category and judging will be in July. It will be the "small" village category, villages with less than 500 on the electoral roll. The plan is to contiwork on the existi nue ng sites around the village. The old seat at the Pinfold needs removing and the gatepost requires repair / replacement. It is hoped to have a work day in February when the area near Conifer Lodge will be tidied following the tree removal last year. A village trail leaflet has been produced and permission was sought to install a plastic weatherproof box in the bus shelter for copies of the leaflet. A request was also made for a display box near the war memorial for the Hunton History Society leaflet to be available. Both were agreed.

- (ii) Greenacres "island" proposal
 HIB had held a consultation event and coffee morning on 13th
 January to explain the seating proposal for the area and seek
 views and opinions. The feedback was overwhelmingly positive.
 A report summarising views and representations had been
 ciculated in advance. There is wide support for the accessible
 seating and area and the proposed planting. It was suggested
 hard landscaping might be extended to the dog waste bin
 location which is currently very muddy. The PC gave it's support
 to the development and asked that HIB proceed with enquiries
 of Highways and utilities.
- (iii) Grasscutting contract
 Cllr Smith updated the meeting, no further tenders for the
 contract have been received, just the two quotes previously
 discussed. The merit of a further 3 year contract was discussed
 and agreed. Flexibility to amend the number and / or timing of
 cuts was discussed noting that that events eg school sports day
 should be accommodated. The grasscutting period is expected
 to be mid March to mid October.

It was proposed that the grasscutting contract should be awarded to Gareth Hastie on a 3 year term, proposed Cllr Smith seconded Cllr Wyatt.

(iv) Blocked Right of Way Cllr Knight informed the meeting that she has been in contact with the NYC Rights of Way Officer regarding the blocked right of way, further information had been requested. The original closure application had been made by Yorkshire Water so it is their responsibility to remedy the situation.


(v) Willow trees on playpark
